**APPENDIX A - ADDITIONAL PARTY INSURANCE AND INDEMNIFICATION AGREEMENT**

This Additional Party Insurance and Indemnity Agreement (“**Agreement**”) is made and entered into upon full execution of the parties hereto by and between the Customer and Additional Party specified below.

**NOW THEREFORE**, in consideration of the promises and mutual agreements contained in this Agreement, it is hereby agreed between the parties as follows:

- Purpose of Agreement.** Customer has entered into an agreement (“**Original Agreement**”) with ROAD ATLANTA, LLC (“**Road Atlanta**”) for access and use of space located at 5300 Winder Highway, Braselton, GA 30517 (“**Facility**”) for the purpose(s) and on the dates set forth in the Original Agreement. Customer desires to have Additional Party and Additional Party agrees to provide services during the Event(s) at the Facility.
- Terms and Conditions.** As required under the Original Agreement, Customer has provided to Additional Party a copy of the terms and conditions set forth in the Original Agreement. Additional Party has been issued a copy of these terms and conditions and agrees to follow all terms and conditions, including without limitation, the indemnification and insurance obligations set forth below.
- Insurance.** Additional Party shall provide Customer (to provide to Road Atlanta) a certificate of insurance evidencing the required insurance coverage stated below and Additional Party agrees to maintain such insurance with a reputable company during all times Additional Party is at the Facility. Such certificate of insurance shall specifically state that the insurance is primary and non-contributory over any other insurance that may be available to an Indemnified Party (defined below), and that a waiver of subrogation shall apply in favor of the Indemnified Parties. Should the above described policy(ies) be cancelled before the expiration date thereof, notice will be delivered in accordance with the policy provisions.

**Commercial General Liability Coverage:** Commercial general liability policy (including personal injury and contractual liability) with a combined single limit of not less than One Million Dollars (\$1,000,000) per occurrence; Two Million Dollars (\$2,000,000) aggregate.

Such policy shall name as additional insureds the “**Indemnified Parties**” as follows: ROAD ATLANTA, LLC, its parent company, subsidiaries, and affiliated companies and each of their respective shareholders, members, officers, directors, agents, employees, sponsors, trustees, receivers, successors, and assigns.

**Workers Compensation:** Compensation insurance with minimum limits equal to the statutory requirements for all states of operation hereunder, including employer’s liability.

- Indemnification.** Additional Party shall indemnify, hold harmless, and defend the Indemnified Parties against any and all losses, damages, liabilities, deficiencies, claims, actions, judgments, settlements, interest, awards, penalties, fines, costs, or expenses of whatever kind, including reasonable attorneys’ fees, arising out of any third-party or direct claim alleging or arising out of: (i) Additional Party’s breach of this Agreement; or (ii) any negligent or more culpable act or omission of Additional Party’s, employees, agents and representatives (including any reckless or willful misconduct) in connection this Agreement. Additional Party’s obligations hereunder to defend shall extend to claims alleging the sole negligence, willful misconduct or violation of law of an Indemnified Party when combined with other claims triggering Additional Party’s obligation to indemnify, provided however that upon the final adjudication by a court of competent jurisdiction or written settlement between the parties, Additional Party shall be reimbursed for the portion of fees or losses so adjudicated as the responsibility of an Indemnified Party. All of the provisions of this Section shall survive the expiration or termination of this Agreement.
- Third Party Beneficiary.** The parties hereby designate the Road Atlanta as a third-party beneficiary of this Agreement and shall have a right to enforce all provision of this Agreement.
- Track Access.** Additional Party understands and agrees that access to the Facility is subject to Road Atlanta receiving a copy of this Agreement and a certificate of insurance showing Additional Party’s compliance with the insurance obligations above.

**Additional Terms.** Capitalized terms used and not defined in this Agreement shall have the meanings given to them in the Original Agreement. Each of the individuals executing this Agreement certifies that he or she is duly authorized to do so.
